### AUTISM

### **Social Interaction**

1. Normal early development : At 3 months babies babble 'conversation' with mother, eager demand for social interaction

2. Impairment of reciprocal interaction.

3. Deficits on 'Theory of mind'



### Communication

- Second year of life- Development of speech
- Delay in development of speech and quality of speech



# Imagination

- Development of imagination with pretend games
- Act out thoughts and actions of other persons
- Developing of theory of mind
- Abstract thinking and transition from concrete to abstract thinking

- Gender?




# Managing Autism

### Autism Spectrum






# Comorbidity

'Better Services for the mentally handicapped', DoH 1971....beginning of deinstitutionalisation Mansell report 1993 DDA 1995 Valuing People, DoH 2001 Mansell report (revised) 2007 Winterbourne- BBC Panorama programme 2011 DoH Winterbourne view – Concordat of Action 2012- Rapid reduction of beds by 1 June 2014 - all inappropriately admitted people in community - PCTs to have a list of all PWLD in hospital



- 'Time for Change'- Sir Stephen Bubb 2014
- Transforming Care for People with Learning disabilities- Next steps
- 'Winterbourne View- Time is running out'- 2015
- LD census stagnation at around 2600
- 'Building the right support'- 2015

Transforming Care Model Service Specification 2017- challenges

Restricted patient Interface with CTRs Conducive to aim and objectives of TC? *PJ (A Patient) v A Local Health Board* and *Secretary of State for Justice v MM*. Court of Appeal 2017 MoJ guidance January 2019



Transforming Care Model Service Specification 2017- challenges

The scope of enhanced services is suggested to be wider than LD Widened to include people with ASD Care pathways into community –'the bottleneck' Transfer of funding between specialist to local services



### Autism and the Mental Health Act

The 'mental disorder'

- 2007 amendment introduced 'mental disorder'
- Autism is a 'mental disorder'- ICD 10 Pervasive developmental disorder. DSM V- ASD
- With/ without learning disability where seriously irresponsible and abnormally aggressive behaviour becomes a determinant



### Autism and the Mental Health Act

Nature of the disorder

- Neurodevelopmental disorder
- From early childhood
- However may be diagnosed later in life
- 'Chronic' condition
- Not 'curable'



# Autism and the Mental Health Act

#### Degree of disorder

- Chronic disorder
- Neurodevelopmental disabilities that are life long
- BUT
- There are environmental influences that affect presentation



### Case Example

- 30 yr old man
- Schizophrenia, ASD, PD and attachment issues
- History of severe emotional and physical abuse as a child
- Special schooling
- Chaotic family environment and violence
- Multiple admissions under MHA non compliance and substance misuse
- Weapons
- Last 7.5 years in secure care low and medium
- Transferred Jan 2019



### Case example

- Difficult first few months with difficult to manage behaviours
- Leave was commenced after 2.5 yrs
- Incidents eventually led to seclusion and LTS
- Move to flat
- Now having unescorted leave
- Being discharged soon
